## Nomination Process Overview

### 2a. Global Humanitarian Award Criteria:

Herbalife Nutrition Foundation has established the HNF Global Humanitarian Award to recognize Herbalife Independent Distributors and Members who exemplify the foundation's mission and, through their outstanding involvement and dedication, have made a significant contribution to changing lives.

The Herbalife Nutrition Foundation Board of Directors will be selecting one Regional Humanitarian Award recipient from each region. The Global Humanitarian Award recipient will be selected from the pool of Regional Humanitarians, and be recognized at the 2020 Herbalife Honors in Los Angeles, USA. Each Regional Humanitarian Award Recipient is eligible to have a US\$2,000 donation made on their behalf by HNF to the charity of their choice. The Global Humanitarian Award recipient is eligible to have a US\$10,000 donation made to the charity of their choice

### 2b. Eligibility:

Any Herbalife Distributor (President's Team or above) who has had a record of sustained giving and volunteerism and have, through their efforts, made a significant contribution to changing lives on a community, national and/or international level.

### 2c. Nominations:

The Herbalife Nutrition Foundation Humanitarian Awards Committee shall solicit and receive nominations for this award. The award is not an annual award and may not be presented in a year when no nominee satisfactorily meets the criteria.

### 2d. Nomination Instructions:

The nomination should describe why the nominee is worthy of the award and speak to the attributes HNF will use in evaluating nominations.

Both nominee and nominator must be in good standing with the company and have had no compliance infractions for two years preceding the award.
